#### **Club Constitution**

- How a club should function
- Membership status / qualification / rights
- How the committee is appointed
- How often it should meet
- Who is eligible to serve

#### Requirements after incorporation

- Lodgment of annual return and statement of accounts
- Changes of public officer (Secretary) or committee members must be reported in annual report
- Secretary is responsible for ensuring the club complies with the act
- •Incorporation numbers (ABN) must appear on club documentation

- My experience over the years
  - Not an accountant
  - Very limited changeover
  - Own it
  - Greater accountability, particularly since salary cap



- Good Governance
  - Use technology, quickbooks or Xero (or equivalent)
  - 2 to sign (challenge with debit/credit card)
  - o Do a budget
  - Regularly report, not just bank balance, P & L noting variations
  - Cyber crime is a real issue
  - Square or eftpos
  - No cash payments
  - Annual report
